It is the policy of Danner, Inc. to discontinue business with retail customers that sell Danner products below Danner's published Suggested Minimum Retail Price. When Danner becomes aware of such pricing, Danner reserves the right to decline to sell the retailer involved any more products of the style or styles affected. If the retailer makes below the published Suggested Minimum Retail Price, Danner reserves the right to close the retailer's account with respect to all styles and may accept no further orders for any Danner products.

This is a unilateral statement of Danner's policy and the implementation of that policy will likewise be unilateral. Retailers are free to sell Danner products at any price they choose, but should be

aware that the consequence of selling those products below Danner's Suggested Minimum Retail Price include discontinuation of affected styles and, ultimately, loss of Danner account status The following activities will not be construed to be in violation of Danner's Minimum Retail Price policy:

· Sales to store employees for personal use.

· Year round store-wide loyalty programs

· Sale of close-out, discontinued or otherwise distressed merchandise.

· Seasonal (once every six months) short sales and promotions. Sales/promotions not to exceed 14 days, and length of sales must be clearly stated in dealer literature

Sales by Government agencies or departments for provision or resale to employees of those departments in connection with their official duties

· Quantity discounts for bids issued by Federal, State, local or other government agencies.

Danner has taken such measures as it deems appropriate to keep itself informed about pricing activities of retailers who purchase its products. Danner does not seek and will not accept communications from retailers or other third parties about the pricing activity of retailers selling Danner products, Danner employees are under instructions not to solicit, receive, or follow-up on such communications. Written communications on that topic will be returned without review

Danner, Inc. allows its dealers to take advantage of sales via their own custom webstore/website - however, it is critical that prior approval and review of all policies pertaining to Danner, Inc. and

its brands be reviewed to ensure compliance with all Danner, Inc.'s corporate standards. The following outlines Danner, Inc.'s Internet Policy: 1. Any e-commerce or content website containing Danner, Inc. product(s) and/or information (Danner or LaCrosse) must be approved as such and will be treated like any new physical location -

An open retail door does not automatically authorize you to sell Danner and LaCrosse prod- ucts on-line.

2. A dealer or distributor site should be easily identifiable as a site belonging to the specific dealer or distributor and cannot be represented as

part of Danner, Inc. Use of a domain name should not contain reference to any specific Danner, Inc. brand.

3. All on-line product imagery, logos, affiliate logos and policy documents used must be provided by or approved by Danner, Inc. Use to be per documented graphic standards provided by Danner, Inc. and be pre-approved by Danner, Inc. before going live line.

4. Information and HTML or other source code on any Danner. Inc. site may not be duplicated, or directly copied, 5. Use of affiliate logo's and reference must comply with the specific affiliates copyright policies.

6. Links to any Danner, Inc. site will be allowed, however, notification to the Danner, Inc E-commerce Webmaster must be provided in advance of the use of the link.

7. MRP policies must be strictly complied with. Action taken by Danner, Inc. will be taken unilaterally and could include terminating both the on- line account as well as the brick-and-mortar operation. *See Danner MRP Guidelines for details 8. Danner, Inc. reserves the right to terminate an account's on-line business at our discretion.

9. An on-line retailer must take possession of a core assortment of inventory. Danner, Inc. will not fulfill drop-ship orders that make up more than 35% of the retailer's business.

TERMS & CONDITIONS OF SALE

1. Orders. All orders placed by Customer shall be subject to acceptance or rejection by Danner, Inc. ("Danner") at Danners corporate office in Portland, Oregon. No order shall be binding on Danner until the earlier of Danners acceptance in writing or shipment and, in the case of acceptance by shipment, only as to the portion of the order shipped. No order may be canceled or modified by Customer after acceptance, unless Danner, in its sole discretion, elects to accept such cancellation or modification. All requests for cancellation or modification of an order must b

submitted to Danner in writing at least 30 days prior to the requested start shipment date.

2. Exclusive Terms and Conditions of Sale. Customer acknowledges and agrees that all sales of products by Danner shall be governed solely and exclusively by the terms and conditions of sale set

forth herein, which terms and conditions shall supersede and prevail over all terms and conditions of Customer's order. Danners acceptance of a customer order is expressly conditioned on Customer's acceptance of the terms and conditions of sale set forth herein in their entirety without any additions, deletions, modifications or exceptions. Any terms or conditions submitted by Customer (in any purchase order, written instrument, or other communication) that are different from or in addition to the terms and conditions contained herein are hereby objected to and rejected by Danner, shall not be effective or binding on Danner, and shall not become a part of the contract of purchase and sale between Customer and Danner. Danners silence or failure to respond any different terms or conditions submitted by Customer shall not be deemed to be an acceptance or approval there 3. Price. Danners prices vary depending on the type of product ordered. Danner reserves the right to change its prices, and any price quotation made to Customer, at any time without notice. All prices charged Customer are exclusive of freight, shipping and insurance charges, and any sales, use, excise or similar taxes, all of which shall be paid by Customer.

4. Drop Ship Charge and Special Handling Charge, A "Drop Ship" is defined as a direct to consumer order fulfilled directly from Danner Inc. to a location other than a certified Danner acount, All Drop Ship orders to a single location will be charged \$5.00. Danner reserves the right, in its sole discretion, to limit the quantity of products shipped to any such location. If Customer requests any special handling services in connection with these orders, including but not limited to pre-ticketing, special labeling, custom insertions, additional fees may apply. There will be no charge for Small Orders, as defined as orders of less than 6 pair delivered to a certified Danner account

5. Delivery; Risk of Loss. All products sold to Customer shall be sold F.O.B. place of shipment (the "F.O.B. Point"), at which time title to the products shall pass to Customer shall pay all freight, shipping and insurance charges; all sales, use, excise, or similar taxes; and any and all other costs or charges incurred after delivery of the products to the carrier at the F.O.B. Point. All risk of loss or damage from any cause whatsoever shall be borne by Customer after delivery of the products to the carrier at the F.O.B. Point.
